  - 1) department/program warnings for the students
  - 2) so far no from the university
  
6. Restrictions of international funding resource
  - 1) different funding agencies published different policies

- 2) most of them require transparency
- 3) depends on the research program and the project
  
7. Foreign exchange students or other trainees (e.g. foreign government supported researchers)
  - 1) open for global intellectual engagement
  - 2) support for developing connections
  
8. International collaboration
  - 1) depends on funding agencies
  - 2) depends on the research programs
  - 3) contribution clarification in publications
  
9. Review process
  - 1) ERM checks all safety
  - 2) OVPR reviews research security and export control
